

**MINUTES OF THE 28TH STEERING COMMITTEE MEETING (SCM)
OF SOUTH ASIA FORUM FOR INFRASTRUCTURE REGULATION
(SAFIR)**

DATE: 8TH JUNE, 2022

VENUE: TAMARIND HALL, INDIA HABITAT CENTRE, NEW DELHI, INDIA

1. The meeting was chaired by Mr. Samdrup K. Thinley, Chairperson South Asian Forum of Infrastructure Regulation (SAFIR) and Bhutan Electricity Authority.
2. Chairperson CERC in his opening remarks thanked the members for participating in the meeting and emphasized on the importance of SAFIR in providing platform for experience sharing on best practices on infrastructure sectors in South Asian region. He added that SAFIR has been ably assisted by multilateral agencies such as USAID and the World Bank on issues such as regional power market and common minimum grid code
3. Chairperson, SAFIR and CEO of Bhutan Electricity Authority welcomed all dignitaries to the meeting. He observed the importance of this physical meeting which follows after two virtual meets. He further stressed on the issues and challenges faced by the SAFIR members in the energy sector and emphasized on the need of resolution of these issues through regular meetings and discussions.
4. Ms. Chathurika Wijesinghe, Member, Public Utilities Commission of Sri Lanka thanked everyone for coming to the meeting. She also highlighted the issues faced by Sri Lanka and assured the members that the situation is not as grim as it is made out on the media. She invited SAFIR members to visit Sri Lanka for conducting meetings in future. She also looked forward for more

- cooperation between India and Sri Lanka in the power sector
5. Mr. Mohammed Abu Faruque, Member, Bangladesh Electricity Regulatory Commission, greeted the members of SAFIR and conveyed his best wishes to them. He also expressed gratitude on behalf of Bangladesh Energy Regulatory Commission to participate in the meeting.

The Steering Committee thereafter took each of the agenda items for consideration.

AGENDA ITEM 1: CONFIRMATION OF THE MINUTES OF THE 27TH STEERING COMMITTEE MEETING

Dy Chief (RA), CERC explained the action taken on various points in the minutes of 27th Steering committee meeting and sought confirmation of the minutes placed before the Committee. After discussion, the minutes of the 27th SCM were confirmed.

AGENDA 2: ACCOUNTS RELATED ITEMS

(i) Budget for the F.Y. 2022-2023.

1. Deputy Chief (RA), CERC apprised the salient features of the SAFIR budget for the F.Y. 2022-2023, including the projected income and expenditure. The Members were also apprised on the restoration of the membership fees for the F.Y. 2022-2023, due to depletion in the accumulated reserves of SAFIR.
2. Further, the Members were apprised that for the past few years, there was an ongoing issue with SAFIR's banker with regard to the validity period of the "No Objection Certificate" issued by the Ministry of Home Affairs in 2010, for receipt of funds/membership fee from the Members Outside India (FCRA issue). This issue has been resolved by the bankers permitting SAFIR to receive funds into its FCRA

account from Members outside India. Hence, SAFIR Sectt. will be issuing the previous years (viz. F.Y.s 2018-2019 & 2019-2020) invoices on its Members Outside India along with the invoice for the F.Y. 2022-2023.

3. Chairperson, CERC suggested that while the invoices are being issued, SAFIR Secretariat should ensure that the communication clearly indicates that the invoices were being raised for the past periods 2018-19 and 2019-20 (due to resolution of FCRA issues) while the membership fees were waived for 2020-21 and 2021-22 and new invoice was being raised for FY 2022-23

4. On the discussion of the Core Course which is held regularly by SAFIR in coordination with its Members, Member, PUCSL, Sri Lanka suggested to include Indian experience on the subjects of Multi Buyer model, Open Access, Power Exchange as these would be more relevant to Sri Lanka context. She further added that the Core course of SAFIR should also be imparted on the areas of the suggested topics to the participants from Sri Lanka.

With these observations, the Steering Committee approved the budget.

(ii) Audited Accounts of SAFIR for the F.Y. 2021-2022.

Deputy Chief (RA), CERC apprised the salient features of the Annual Accounts of SAFIR for the F.Y. 2021-2022. Thereafter, the Steering Committee approved the Annual Accounts of SAFIR

(iii) Re-appointment of Auditor/Consultants:

1. Deputy Chief (RA), CERC apprised that M/s R.K. Raman & Co., CAs are completing their tenure of five years as Auditors of SAFIR after conducting the audit for F.Y. 2021-2022. Accordingly, the process of appointing a new Auditor will be initiated and quotations will be called from the existing panel of CAs & new CA firms.

2. The Members also approved the proposal for re-appointment of Auditor for conducting the Audit of SAFIR and Consultants for filing the Income Tax Return & FCRA Return of SAFIR for F.Y. 2021-2022. Further, the Members also approved the re-appointment of consultant for filing the GST Returns of SAFIR for F.Y. 2022-2023.

(iv) Membership withdrawal request from SAFIR members, viz. Sikkim State Electricity Regulatory Commission and Assam Electricity Regulatory Commission.

1. Deputy Chief (RA), CERC apprised that Assam ERC vide their letter dated 27th February, 2020 had requested for discontinuation of membership of SAFIR due to financial constraints. However, due to pandemic situation, SAFIR had permitted Assam ERC to continue as a member, as the membership fees was waived for all SAFIR members for the F.Ys. 2020-2021 and 2021-2022. Further, she added that Sikkim State ERC had also, vide their letter dated 16th April, 2021 requested for discontinuation their membership of SAFIR.
2. In this matter, while Chairperson, Sikkim State ERC stated that the decision to withdraw from SAFIR was taken before he assumed charge in Sikkim ERC, he was happy to inform the Forum that Sikkim ERC would continue to be a member of SAFIR and that a letter in this regard will be sent to SAFIR Secretariat.
3. On the same issue, Member, Assam ERC informed the Forum that, vide their letter dated 30th October, 2021, they had already communicated to SAFIR Secretariat to continue their membership in SAFIR. However, as the same was not received by SAFIR Secretariat. Member, Assam ERC stated that the letter will be shared again.

The Steering Committee of SAFIR appreciated the response of both Assam and Sikkim ERCs to continue to be members in SAFIR

AGENDA ITEM 3: ESCAP PROPOSAL FOR CAPACITY BUILDING PROGRAMS FOR REGULATORS IN SAFIR

1. Dy. Chief (RA), CERC apprised the Steering Committee members about the proposal received from the Economic and Social Commission for Asia and the Pacific (ESCAP) Secretariat which is also one of the five regional commissions of the United Nations to conduct capacity building programs for SAFIR to support increased and sustainable power system connectivity – Phase I. She further informed that the trainings would be fully funded by ESCAP and that they had suggested training topics in Electricity trading in a multi-jurisdictional setting; Congestion management for cross-border electricity trading; transmission tariff setting in a regional market; Renewables integration and its impact on electricity systems and markets; end-user electricity tariffs and their affordability; regulatory governance of regional electricity markets, etc.
2. The Steering Committee members observed that the topics suggested by ESCAP are relevant to the South Asian region and therefore, approved the proposal and directed SAFIR Secretariat to send a confirmation of the same to the ESCAP secretariat.

AGENDA ITEM 4: STATUS UPDATE OF ACTIVITIES OF THE SAFIR WORKING GROUP – BY SARI/EI; IRADE

1. Dy. Chief (RA), CERC apprised the SC members about the technical and knowledge support being provided by IRADe through the SARI/EI program to the SAFIR Working Groups, which will end in September 2022, and thereafter requested Project Director, SARI/EI to make a brief presentation on the various

- activities of the SAFIR Working Group.
2. Project Director, IRADe / SARI/EI made a presentation (**Annexure II**) before the Steering Committee. The key features of the presentation included the following:
 - a) TOR of the SAFIR Working Group and its key activities
 - b) Update on the Study on Regulatory interventions for Grid discipline and Grid reliability in the South Asian region ; Study /Research on South Asia electricity/electricity regulations to develop regulatory pathway/Road Map for Electricity/Energy exchange and Energy Cooperation (EC) in SA ; Common Minimum Grid Code for South Asia ; New Study on Assessing the Potential Benefits of Cross Border Electricity Trade, Grid Balancing of Renewable Energy Integration and Ancillary Service Market in the South Asia
 - c) SAFIR Regulatory Newsletter, Compendium of Electricity Regulation of South Asia Countries, Web portal on “South Asia Energy/Electricity Knowledge Resource Database”; South Asia Energy Database; SAFIR Working Group meetings and South Asia Energy Sector Training and Capacity Building program on energy regulation for Energy Cooperation and exchange of electricity in South Asia
 3. The SC members were also informed that the SARI/EI is a long-standing program of USAID which started in the year 2000 and is ending in September 2022 and further, the activities of the program will be carried out by the South Asia Regional Energy Partnership (SAREP) program which is fully funded by USAID .
 4. Ms. Monali Zeya Hazra, Regional Energy Manager and Program Management Specialist, USAID apprised the Steering Committee members that the SAREP program is a 5-year program which was launched on May 2021 but was put on hold, due to overlapping scope of work with SARI/EI program. Hence, once the SARI/EI program comes to an end in September 2022, the future activities of supporting SAFIR will be carried out by RTI under the SAREP Program.

The Steering Committee appreciated the support given by USAID to the SAFIR Working Group and directed SAFIR Secretariat to coordinate in this matter.

AGENDA ITEM 5: PLAN FOR F.Y. 2022-23

(i) SAFIR Infrastructure Conference for F.Y. 2022-23 (ii) Next Steering Committee meeting

1. Dy. Chief (RA), CERC/SAFIR Secretariat updated the Steering Committee members about the SAFIR Infrastructure Conference which is generally conducted in association with multilateral organisations and is fully funded by such organisations. She also informed the members that IRADe in association with USAID under the SARI/EI program has been conducting the Infrastructure Conference for SAFIR since 2016. To this, the representative of USAID informed that USAID would continue to support the SAFIR Conference under the South Asia Regional Energy Partnership (SAREP), a newly launched USAID program from October 2022 onwards.

2. Chief (RA), CERC observed that in the past such conferences were generally conducted back to back with the Steering Committee meetings and accordingly, the same can be planned . As the next Steering Committee is slated to be held in the next financial year, SAFIR Secretariat was directed to coordinate with USAID on working out the necessary arrangements

At the end, the members noted that Mr. P. K. Pujari, Chairperson, CERC is due to retire on superannuation on 11th June, 2022 (this being his last Steering Committee meeting), and placed on record their deep appreciation for the valuable contribution of Mr. Pujari in the activities of SAFIR.

The meeting concluded with vote of thanks to the Chair.


