Shri Gireesh B. Pradhan, Chairperson, Central Electricity Regulatory Commission

(CERC) extended a warm welcome to all members of SAFIR in the twenty second meeting

of Steering Committee (SC)

The welcome address of Shri Gireesh B. Pradhan was followed by the address of Ms.

Shubha Sarma, Secretary, CERC. The Steering Committee thereafter took the following

agenda items for consideration.

Agenda Item No. 1:

Confirmation of the Minutes of the 21st Steering Committee Meeting of SAFIR

held during 25th-27th March, 2015 at Thimpu, Bhutan and Action Taken Report.

The Steering Committee endorsed the minutes of the meeting held during 25^{th} - 27^{th}

March, 2015 at Thimpu, Bhutan. The Committee also discussed and noted the Action Taken

Report.

Agenda Item No. 2:

Financial Statement of SAFIR for the year 2014-15 and Budget for the financial

year 2016-17.

Secretary, CERC explained the salient features of the Balance Sheet and Income &

Expenditure Account for the financial year 2014-15 (as per Annexure-I of the said

Agenda). After discussion, the Annual Accounts of SAFIR for the financial year 2014-15

were considered and adopted.

The budget for the FY 2016-17, (as circulated) was discussed in detail. SAFIR Secretariat proposed to recruit additional staff to take care of the various administrative and research works etc. for which the cost has been factored in the budget. The SC approved the proposal of additional staff as envisaged and the budget has been approved.

After discussion the proposed budget for 2016-17 was approved.

Agenda Item No. 3:

Appointment of Auditor for the Audit of SAFIR for the F.Y. 2015-2016

The Committee was informed that Shri A.K. Awasthi of M/s A.K Awasthi & Co., Chartered Accountants, New Delhi / Kanpur was appointed for auditing the Accounts of SAFIR for the financial year 2014-15

It was discussed with the members on the appointment of auditor for the next financial year. As M/s A.K Awasthi & Co., Chartered Accountants has completed only one year as auditor of accounts of SAFIR, it was proposed to extend the tenure by another year. The proposal was accepted by the Steering Committee

Agenda Item No. 4:

Outstanding membership fee from the Members of SAFIR and withdrawal/cessation from/of the membership of SAFIR

It was highlighted that the membership fee was due from several members and this caused a challenge in carrying out the activities of SAFIR effectively. It was informed that Mr. Samdrup Thinley, Chairperson, SAFIR and CEO, Bhutan Electricity Authrority (BEA) had written to all these members to pay the outstanding membership fee of SAFIR at the earliest. However no acknowledgement or reply was received.

The Committee was also apprised that Central Power Research Institute (CPRI) and Arunachal Pradesh State Electricity Regulatory Commission (APSERC) have requested for withdrawal from the membership of SAFIR citing financial constraints and limited professional interaction with SAFIR in last few years.

After deliberations, it was agreed to accept the withdrawal of CPRI and APSERC. It was also agreed that the existing membership fee structure be continued.

Agenda Item No. 5:

Report of 15th Core Course and conducting of the next Core Course on Infrastructure Regulation and Reforms

Secretary, CERC / SAFIR apprised the members that the flagship Core Course was successfully organized at Administrative Staff College of India (ASCI), Hyderabad, India in November 2015 and the participants were appreciative of the course content. The Steering Committee noted the report of the 15th Core Course of SAFIR held at ASCI, during 16th-18th November, 2015.

Agenda Item No. 6:

Presentation on Regulatory Impact Assessment- Consumer Unity & Trust Society (CUTS)

The presentation on Regulatory Impact Assessment (RIA) was made by Shri Ashwini Swain, Director, CUTS Institute for Regulation & Competition. Copy of the presentation is placed at **Annexure II.**

The key features of the presentation included the following

- ➤ Introduction to RIA: Developed understanding of the key attributes that are the basis of RIA
- ➤ Elements of RIA: The tools such as cost benefit analysis and qualitative techniques related to understanding of the objectives and the concern for stakeholders were discussed
- **Process of RIA:** Provided insight on the process that is employed for RIA
- ➤ **Need for RIA in India:** Discusses the factors highlighting the need for RIA in India
- ➤ CUTS Initiatives on RIA: The initiatives taken by CUTS on RIA in banking, electricity and insurance sector in India were discussed
- ➤ Applications of RIA in Electricity Sector: The initiatives taken by CUTS on RIA in electricity sector were elaborated

➤ **Key Findings:** The key findings with specific focus on the coal, hydro and solar sector were discussed.

The participants were appreciative of the presentation.

The same was considered and approved unanimously by the SC.
